On April 11, 2016, Metropolitan Edison Company, Pennsylvania Electric Company, Pennsylvania Power Company and West Penn Power Company (collectively, FirstEnergy) filed the results of their Request for Proposals (RFP) Processes and Rules (April 2016 Solicitation) for provider of last resort service. The filing includes the proposed bid results for provider of last resort service for the supply for all FirstEnergy Residential and Commercial Customers electing to receive default service from FirstEnergy for the twelve month period beginning June 1, 2016 and for Commercial Customers for the three month period beginning June 1, 2016. The April 2016 Solicitation includes twelve products in a Full Requirements Auction at Docket Nos. P-2013-2391368, P-2013-2391372, P-2013-2391375 and -2013-2391378 (P-2013-2391368 et al).

This filing was submitted in accordance with the RFP Process and Rules filed by FirstEnergy. The RFP Process and Rules were filed pursuant to the Commission's Opinion and Order, entered July 24, 2014, at Docket No. P-2013-2391368 et al.

FirstEnergy requests that the Commission approve the bid results from the April 2016 Solicitation on or before April 13, 2016.


