On November 13, 2024, FirstEnergy Pennsylvania Electric Company (FEPA), on behalf of its four rate districts of Metropolitan Edison Company (Met-Ed), Pennsylvania Electric Company (Penelec), Pennsylvania Power Company (Penn Power), and West Penn Power Company (West Penn), filed the results of its Request for Proposals Process and Rules for the November 2024 Solicitation for provider of last resort service. The filing includes bid results of fifteen products in a declining clock auction for the supply for residential and commercial customers who will receive default service from FirstEnergy within the period June 1, 2025 through May 31, 2027.

This filing was submitted in accordance with the RFP Process and Rules filed by Met-Ed, Penelec, Penn Power, and West Power (now FEPA). The RFP Process and Rules were filed pursuant to the Commission's Order, entered August 4, 2022, at Docket Nos. P-2021-3030012, P-2021-3030013, P-2021-3030014 & P-2021-3030021.


FEPA requests that the Commission approve the bid results from the November 2024 Solicitation on or before November 14, 2024.
